THE IRC'S HEALTH & SAFETY CAMPAIGN

The IRC's Health & Safety Campaign has been very well received by Secondary Schools . The Commission has been visiting schools island wide as part of its sensitization campaign centered around electrical hazards and the many forms in which they exist. The theme of the Campaign is “ **HEALTH & SAFETY - IT'S EVERYBODY'S BUSINESS**” . The Commission has been encouraging Health & Safety practices which will help to mitigate and where possible, eliminate the related injuries, losses or deaths that are associated with such hazards. Though the sensitization had been interrupted due to the passage of Hurricane Maria, the IRC' has persevered in ensuring that every secondary school is sensitized.

Thirteen of the targeted secondary schools on island have so far been sensitized. Both students and teachers have been embracing the information provided, as they recognize the seriousness of hazards and how easily it could negatively impact health, property and the environment.

Some of the topics covered dealt with carbon monoxide as one of the dangerous gases released from generators and its poisoning effects on the human body. Discussions were also held on the importance of wearing protective gears when dealing with electrical current, the proper maintenance and storage of electrical appliances and the need to do

periodic inspection for damaged insulation and cracks.

Students were told of the consequence of overloading circuits, ignoring faulty electrical fan strips, not attending to a defective modified wiring, or to prolonged electrical problems , all of which have been some of the cause of many electrical fires . Emphasis was made on the relevance of placing fire extinguishers at

strategic places at schools / homes/ workplaces. Students realized the importance of keeping electrical appliances out of the reach of children as something they had taken for granted for too long .

The right response to electrical shocks, demonstrating how to separate an individual from the source of electricity ,was also a welcomed eye opener.

Some of the schools sensitized included the St. Mary's Academy, the Wesley High School , the Orion Academy , the Castle Bruce Secondary School, Portsmouth Secondary School, Seventh Day Adventist School, the Goodwill Secondary School and Pierre Charles Secondary School.

CAREC CONFERENCE 2018—MIAMI FLORIDA

The Carilec Renewable Energy & Smart Grid Conference was held in Miami Florida from September 23rd to 27th 2018. The theme of the conference was “Energy Resilience and Independence”. Panel discussions were held on various topics to include:

- ◆ Understanding the trade off when adding renewable storage to an island utility grid;
- ◆ Grid Friendly Microgrids– How microgrids can create resiliency and independence for the off - takes;
- ◆ Capacity Building —An imperative in green energy transition for the Caribbean;
- ◆ Supporting Energy Sector Development through effective knowledge Management;
- ◆ Better & Cleaner fuel– Achieving Emission reduction in the Caribbean;
- ◆ The path to 100% diesel free operating electric utilities in the Caribbean;
- ◆ Electric vehicles– is it the silver bullet for electric utilities;

LATIN AMERICA & CARIBBEAN (FFRE) WORKSHOP

The Latin America's Fossil Fuel to Renewable Energy (FFRE) workshop organized by the United Nations Office of Sustainable Development (UNOSD) in collaboration with United Nations Development Programme (UNDP) and United Nations Costa Rica, brought together participants from government organizations from twenty one (21) countries in Latin America and the Caribbean. The workshop was held in Fondacion Omar Dengo, San Jose, Costa Rica from the 12th to 16th of November 2018. The facilitators of the workshop were from UNOSD & the United Nations Development of Economic and Social Affairs (UNDESA).

The facilitators were able to inform participants on the global trends and present thinking regarding Environmental Fiscal reform and in particular, Fossil Fuel Subsidiary Reform and the importance of the FFRE process in the attainment of many of the sustainable development goal.

Broadly the FFRE Workshop focused on topic such as Environmental Fiscal Reform in theory & practice, the Political Economy of Energy Policies, as well as designing robust FFRE policies. The Independent Regulatory Commission's Utility Engineer, Mr. Felix Julien, was in attendance.

OOCUR ECONOMETRIC & STATISTICAL TRAINING

The Organization of Caribbean Utility Regulators , held a five-day workshop on Econometric and Statistical Techniques in Port of Spain Trinidad , from August 20th to 24th 2018.

The objective of the workshop, was to provide Caribbean Utility Regulators with an introduction to the fundamental methods of Econometric.

Participants were provided with techniques to develop more efficient ways to carry out routine but vital operation , principally, for Forecasting and Policy Analysis. The facilitator of the workshop was Dr. Patrick Watson of Trinidad. IRC's Financial Analyst Mrs. Connie Joseph-Louis and Utility Engineer Mr. Felix-Julien , attended the workshop.

OECS GEOTHERMAL ENERGY ROUND TABLE

The Organization of Eastern Caribbean States Geothermal Roundtable, was held in Harbor Club Hotel St. Lucia , on December 5th 2018, under the theme “Advancing Geothermal Energy for Economic Development Resilience”. A key objective of the Roundtable was to obtain a status report on the achievements with respect to Geothermal Energy in the region.



There were various presentations at the session. Some of the topics addressed were:

- ◆ Risk Management for Geothermal Progress in the Caribbean;
- ◆ Financing Geothermal Energy in the Caribbean;
- ◆ Geothermal Energy Interconnection.

The presentation on Geothermal Energy Island Interconnection generated discussions on the potential for export of geothermal energy through submarine cables in the region. Reference was made on the need for greater regional collaboration on geothermal energy.

Currently seven (7) OECS member states are pursuing geothermal energy as part of their renewable energy mix. The Independent Regulatory Commission’s Executive Director Mr. Justinn Kase represented the Commission at the Roundtable.

USTDA MISSION

The United States Development Agency (USTDA) invited the Independent Regulatory Commission to attend a Caribbean Microgrid Infrastructure Reverse Trade Mission from April 28th to May 4th 2019. The Trade Mission is an approach by the USTDA , inviting utilities and other electricity sector agencies and organizations within the Caribbean, to inform the targeted audience of technology business of funding opportunities available to them, for securing Technical Assistance, Studies and Expertise, necessary for establishing a microgrid infrastructure.



Visits were carried out to two sites with established microgrid operations. IRC's Executive Director Mr. Justinn Kase along with the other participants, were able to observe how the sites took measures in making their microgrids more resilient to severe weather events. The sites had previously experienced damage from a few storms.
